SERVICES PROVIDED

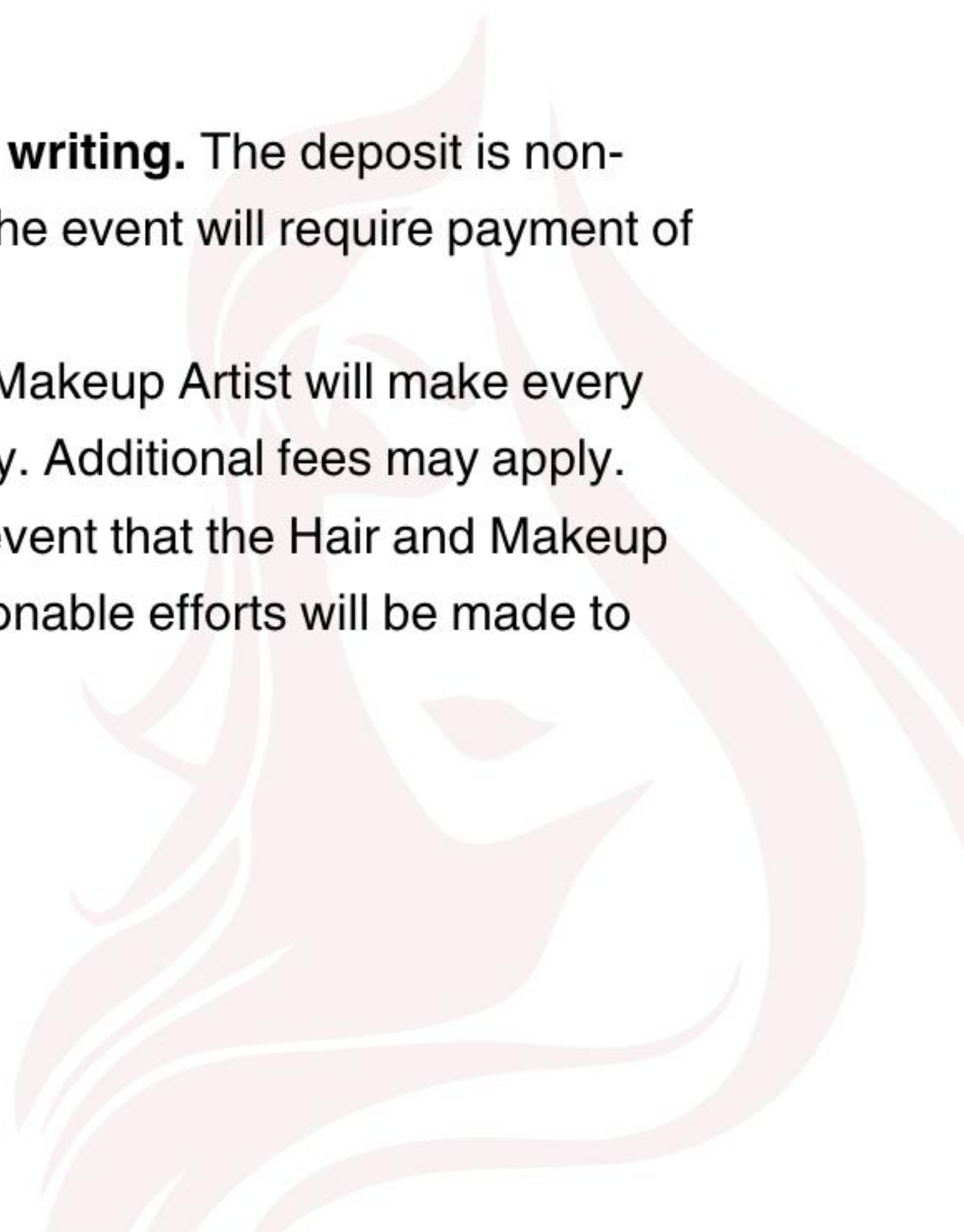
- **Bridal Hair and Makeup:** Consultation, trial session, and day-of-wedding hair styling and makeup application.
- **Bridesmaids/Family Hair and Makeup:** Bridesmaids or family members will receive hair and makeup services up to the agreed-upon number.
- **Trial Session:** The trial session includes 1 hair style and one makeup look, small adjustments, up to 90 min. appt. If the client wishes to schedule an additional trial or make significant changes, additional fees will apply. Trial sessions are non-refundable. Reference photos required.
- **Additional Services:** false lashes, hair extensions, flower placement [hair]

OTHER FEES

- **Travel Fees:** Travel fees of \$3 USD per mile will apply if the event location is more than 60 miles from Woodstock, GA.
- **Accommodation:** If the event requires an overnight stay, the client will be responsible for providing accommodations or covering the cost.
- **Additional Stylists:** If additional hair or makeup artists are required to accommodate a large bridal party or unreasonable timeline the client will be responsible for any additional fees. The client will be informed in advance if more artists are needed to meet the timeline. Assistants are paid an hourly wage. Bride is responsible for said wage or can be equally split into bridal party.

CANCELLATIONS AND REFUNDS

- **Client Cancellations: Cancellations must be made in writing.** The deposit is non-refundable. Cancellations made less than 7 days before the event will require payment of 50% of the total cost.
- **Rescheduling:** If the event is rescheduled, the Hair and Makeup Artist will make every effort to accommodate the new date, subject to availability. Additional fees may apply.
- **Hair and Makeup Artist Cancellations:** In the unlikely event that the Hair and Makeup Artist must cancel, the deposit will be refunded, and reasonable efforts will be made to find a replacement artist.



HEALTH AND SAFETY

- **Allergies/Skin and Scalp Sensitivities:** The client agrees to inform the Hair and Makeup Artist of any known allergies or sensitivities related to their skin or scalp. The Hair and Makeup Artist is not liable for any reactions or complications arising from undisclosed conditions.
- **Sanitation:** The Hair and Makeup Artist follows strict sanitation practices, including the proper cleaning and sterilization of tools, brushes, and equipment.
- **Health Conditions:** The client agrees to inform the Hair and Makeup Artist of any health conditions that may affect the hair styling or makeup application process.

PHOTO RELEASE

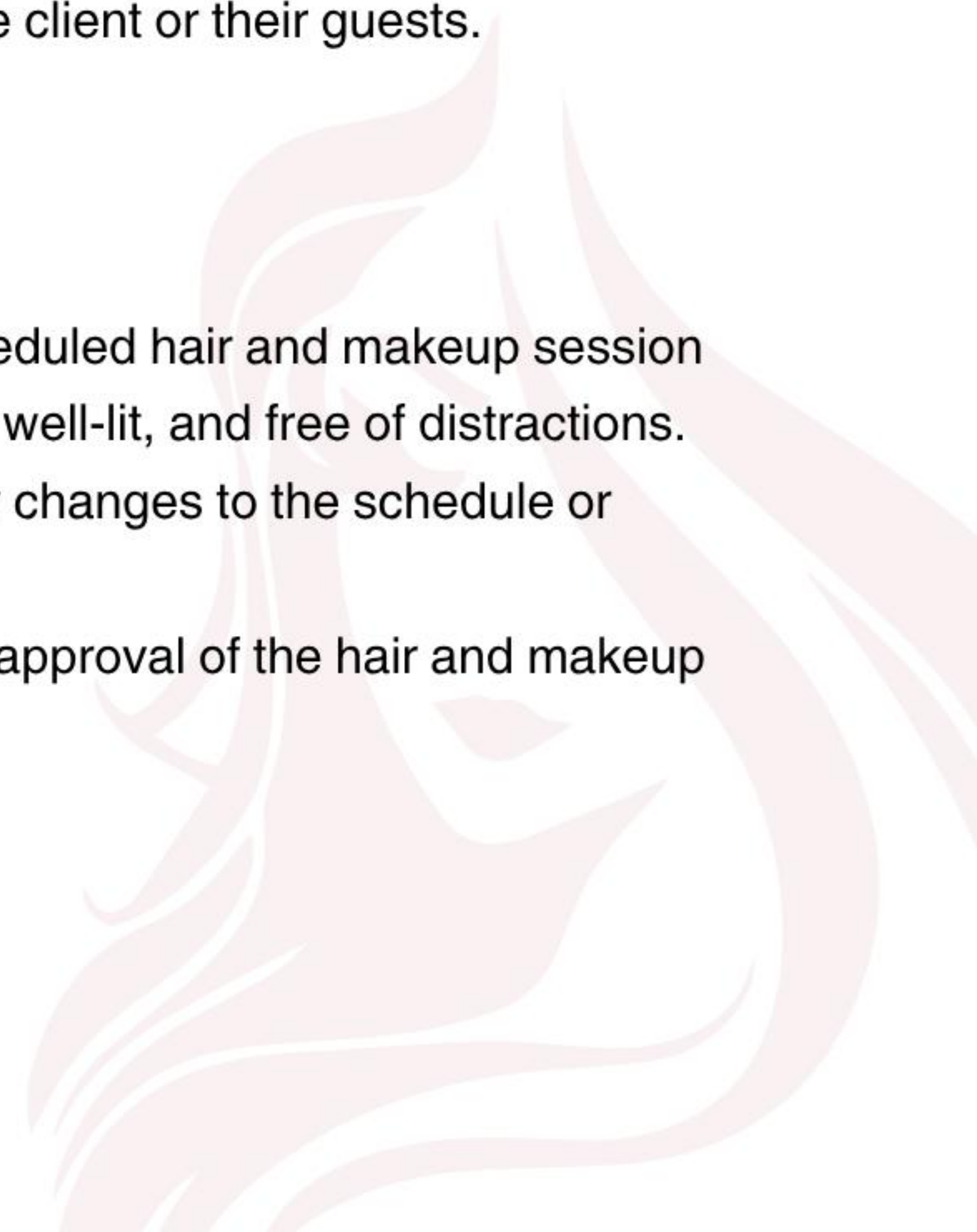
- **Permission to Use Photos:** The client grants the Hair and Makeup Artist permission to use photos of the hair styling and makeup for promotional purposes, including social media, website, and portfolio, unless the client opts out in writing.
- **Client's Rights:** The client retains the right to request that specific photos not be used for promotional purposes.

LIABILITY

- **Limitation of Liability:** The Hair and Makeup Artist is not liable for any injury, illness, or loss caused directly or indirectly by the services provided.
- **Damage to Property:** The client agrees to be responsible for any damages to the Hair and Makeup Artist's property or equipment caused by the client or their guests.

CLIENT RESPONSIBILITIES

- **Preparation:** The client agrees to be on time for the scheduled hair and makeup session timeline and to ensure that the preparation area is clean, well-lit, and free of distractions.
- **Communication:** The client agrees to communicate any changes to the schedule or services as soon as possible.
- **Final Look Approval:** The client agrees to provide final approval of the hair and makeup before leaving the preparation location.



FORCE MAJEURE

- **Unforeseen Events:** The Hair and Makeup Artist shall not be liable for any failure to perform services due to circumstances beyond their control, including but not limited to natural disasters, acts of war, public health emergencies, or government restrictions.
- **Notification:** In the event of a force majeure, both parties agree to notify each other promptly and make reasonable efforts to reschedule the services.

ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties and supersedes any prior discussions or agreements. Modifications to this Agreement must be made in writing and signed by both parties.

GOVERNING LAW

This Agreement shall be governed by the laws of the State of Georgia.

Bridal Hair and Makeup MORNING OF PREP

CLIENT RESPONSIBILITIES

- **Preparation:** Be on time for the scheduled hair and makeup timeline and ensure that the preparation area is clean, well-lit, and free of distractions. Timeline provided is 30 min time slots for each service, and an hour for the bride. **All parties need to be present at start of timeline.** If assistant was hired, they will be prepping hair/ curling who's on deck. Timeline is subject to be pushed up sooner depending on speed of providers. If the next client isn't present and ready to receive services, the timeline is disrupted. Please share to parties receiving services to ensure there's no stress or miss communication. The night before we recommend a full nights rest and staying hydrated. No bra straps or hair ties on wrist day of! **Clean dry hair, clean moisturized skin, clients shade foundation & 1 finalized inspiration picture ready to show for each service. Remainder of balance is required in cash after services are rendered.**
